

AMIGOS BRAVOS FINANCIAL STATEMENTS ARE CURRENTLY PREPARED BY AN INDEPENDENT CPA FIRM. MONTHLY FINANCIAL STATEMENTS ARE REVIEWED BY THE EXECUTIVE DIRECTOR AND THE TREASURER, WHO COMPILES A QUARTERLY "TREASURER'S REPORT." THE BOARD OF DIRECTORS REVIEWS AND APPROVES THE QUARTERLY FINANCIAL STATEMENTS.

FOR AT LEAST THE PAST FIFTEEN YEARS, WHEN THE REVENUE THRESHOLD OF \$500,000 HAS BEEN EXCEEDED, CONSISTENT WITH NEW MEXICO'S REQUIREMENTS FOR NON-PROFIT ORGANIZATIONS THE ORGANIZATION HAS PREPARED AN AUDIT WITH AN INDEPENDENT CPA FIRM. AUDIT RESULTS ARE REVIEWED BY THE EXECUTIVE DIRECTOR, THE TREASURER, AND THEN THE FULL BOARD OF DIRECTORS.

PRIOR TO FY17, THE ORGANIZATION'S FORM 990 WAS PREPARED BY AN INDEPENDENT BOOKKEEPER AND REVIEWED BY THE EXECUTIVE DIRECTOR, THE TREASURER, AND THE AUDITOR. FOR FY17, THE ORGANIZATION'S FORM 990 WILL BE PREPARED BY AN INDEPENDENT CPA FIRM AND A SIMILAR LEVEL OF REVIEW WILL BE APPLIED.
